## Advantages of company in JAFZA

- High level of confidentiality. List of directors and shareholders is closed and can be disclosed only in accordance with the decision of the court
- Possibility of 100% foreign ownership
- No taxes (except VAT 5%)
- No currency control
- No restrictions on the employment of foreign workers
- Highest level of confidentiality
- Possibility to obtain tax resident status
- The company has the right to obtain a resident visa for shareholders and employees
- Absence of customs duties when working with the Gulf countries.

# **Types of companies**

- Free Zone Company (FZCo) 2-5 shareholders. Shareholders can be individuals (person) and/or non-individuals (company). An FZCo is essentially a Limited Liability Partnership within the Free Zone
- Free Zone Establishment (FZE). FZE registration allows for a single shareholder. Shareholder can be an individual (person) and/or non-individual (company). An FZE is essentially a Limited Liability Partnership within the Free Zone.
- **Branch of existing company.** A branch is considered a legal entity of its parent company. An entity established outside of the Jebel Ali Free Zone may establish a branch within JAFZA.



#### Licenses

#### - Service

A Service License allows the holder to carry out the services specified on the license within the Free Zone.

## - Logistics

This License allows firms to engage in logistic services such as Cargo (sea, land, air), warehousing, storage, packing, transshipment and distribution.

#### - Trading

Allows the holder to import, export, distribute and store items specified on the license. In addition to this, there is a General Trading License which allows the holder access to a wider range of activities and a broader range of items on the license.

#### - Industrial

An Industrial License allows the holder to import raw materials, carry out the manufacture of specified products and export the finished product. In addition, there is also the National Industrial License, issued for manufacturing companies with at least 51% Arabian Gulf Co-operation Council (AGCC) ownership. This license allows the holder to have the same status as a local or AGCC inside the UAE.

## **Shareholders and management**

Shareholders may be an individual and/or company. There is no maximum number of the shareholders. Corporate director is not allowed. There is no maximum number of the directors. There are no residency requirements for shareholders/ directors/ manager.

## **Share Capital**

There is no minimum amount of share capital. Payment of the share capital is not required.

If it is necessary to obtain a Share Certificate (Certificate confirming the ownership of shares), the paid-up share capital must be at least \$273 973 / AED1 000 000.

# Office spaces

Real office required. Office of Business Centre Company can be used. The minimum office area is 26,88 sq m.

## **Visas**

Each company entitled to a certain number of residence visas which depends on the size of the office (approximately 1 visa for each 9 sq m).

# Accounting and audit

Every Company shall keep accounting records sufficient to show and explain the transactions of such Company. A copy of the annual accounts (audit report) of each Company shall be delivered to the JAFZA within 3 months of the end of the financial year of the Company. The first "financial year" of each Company shall commence on the date of its registration as disclosed in its Certificate of Formation. The Owner may determine the length of the financial year of its Company by Owner's Declaration provided that no first financial year may exceed 18 months or be for less than 6 months.

#### Note:

- 1. The term of registration of the company 3-4 weeks from the date of submission of documents.
- 2. A personal visit of a shareholder or a representative acting on the basis of a power of attorney legalized in the UAE is required.
- 3. Specimen signature attestation: 15\$ / AED 50 per person.
- 4. Signboard 30\$ / AED 110 (one-time payment).
- 5. Establishment card 132\$ / AED 480.
- 6. Application fees 137\$ / AED 500.
- 7. Insurance for the office 30\$ / AED 100.
- 8. Liquidator's report cost is approximate, as it differs from company to company based on the amount of transactions. Liquidation cost mentioned is the standard cost, there will be additional charges for NOC from various departments based on the activities.
- 9. The Proofs of residence (address proofs) of the Shareholder, Director, Manager is required (for example, receipts for payment of utility bills, but not older than 3 months).
- 10. If the shareholder is a legal entity registered outside the UAE, its documents could be subject to legalization for an additional fee in accordance with the prices established by the authorities.
- 11. Receiving a P.O. Box for your correspondence is possible both on the free zone territory, and by using the service Walton Consultants DMCC "Correspondence", which allows to obtain the P.O. Box of your company to the address of Walton (\$150 / AED548) or to the address of your company (\$300 / AED1095), in all cases, the check will be carried out once a month.
- 12. Company stamp (on request) \$60 / AED219.
- 13. Courier services from \$120.
- 14. The rate of the government fees can be changed by decision of free zone administration.
