General Manager is required – can be one of the shareholders/ directors. Secretary is required - can be one of the shareholders/ directors.

Share capital

There is no need to pay.

Each company is entitled to a certain number of residence visas.

1. The term of registration of the company – 2 days from the date of submission of documents.
2. A personal visit of a shareholder or a representative acting on the basis of a power of attorney legalized in the UAE is required.
3. The Proofs of residence (address proofs) of the Shareholder, Director, Manager is required (for example, receipts for payment of utility bills, but not older than 3 months).
4. If the shareholder is a legal entity registered outside the UAE, its documents could be subject to legalization for an additional fee in accordance with the prices established by the authorities.
5. Company stamp (on request) - \$60 / AED219.
6. Courier services – from \$120.
7. The rate of the government fees can be changed by decision of free zone administration.
